PROCEDURE

Step	Process
1	GloBiz Link will familiarize you with the general requirements of the Portugal Golden Visa program, including eligibility criteria and necessary documentation. Also, we will need you to prepare the required documents such as a valid passport, criminal record certificate, and supporting documents.
2	We obtain a Portuguese Tax Number (NIF) for you and appoint a fiscal representative. The NIF is essential for tax purposes. We will open a bank account for you remotely.
3	We assist you in choosing an eligible investment option, such as an Investment Fund, Job Creation, or Donation. Make the required investment according to the specific criteria of your chosen option.
4	We submit your Golden Visa application, provide all required information, the necessary documents, and pay the application fee.
5	We schedule an appointment at the date it will be convenient for you to provide biometric data, including fingerprints and a photograph. This step typically requires physical presence in Portugal.
6	Once the application is approved, you will receive a residency permit (Golden Visa) valid for an initial period.

CITIZENSHIP

Upon completing 5 years of residence and having spent a minimum of 35 days in Portugal, the investor and his dependents become eligible to divest their investment and immediately qualifies for Permanent Residence. Simultaneously, they can apply for Citizenship, subject to additional requirements, including knowledge of the Portuguese language at the A2 level and displaying ties to Portugal.

Path to apply for the Citizenship:

1. Initial Golden Visa residence permit valid for 1 year, obligation to stay in Portugal for at least 7 days during this year
2. Second Golden Visa residence permit valid for 2 years, obligation to stay in Portugal for at least 14 days during these 2 years
3. Third Golden Visa residence permit valid for 2 years, obligation to stay in Portugal for at least 14 days during these 2 years
4. Permanent Residence Permit and application for the Citizenship
