TIMELINES

<p>INITIAL STEPS (1–2 months)</p>	<ul style="list-style-type: none">• Sign engagement contract and make the first business and professional fee payment.• Provide a certified passport copy and CV for matching with an appropriate business idea.• Sign up for the next available business training course.• Begin collecting required documents. Note: IELTS level 5 in each section minimum is required.
<p>TRAINING COURSE AND LETTER OF SUPPORT (3–4 months)</p>	<ul style="list-style-type: none">• Attend a ten–day business training course hosted by an incubator organization in Canada or another country.• Graduate from the business training course.• Make the second payment for business and professional fees (held in escrow until PR status is obtained).• Within 3 months of graduating, receive the Letter of Support for PR application.
<p>PERMANENT RESIDENT APPLICATION AND MOVING TO CANADA (5–6 months)</p>	<ul style="list-style-type: none">• Apply for PR at the Federal Level using the Letter of Support.• Go through the regular Canadian Federal PR process with support from our Canadian attorney.• Once PR is granted, the client and family can move to Canada to start a new life.
