REQUIRED DOCUMENTS

Birth Certificate:

 Each copy must be stamped and authenticated OR Apostilled in accordance with the Apostle Convention.

Certificate of Residence:

- Proof of address required; Bank statements or utility bills NOT accepted.
- Each certificate must be stamped and authenticated OR Apostilled.

Marital Status:

- Vital Record showing husband, wife, and children.
- o If married: Marriage Certificate.
- o If divorced: Divorce Certificate.
- If widowed: Spouse's Death Certificate.

Passport:

Copy of the original Passport.

Translation of Documents:

Original and Notarized Turkish translation required for all documents.

Power of Attorney:

Must be granted.

Application Forms:

All forms must be completed and filled in correctly.



CITIZENSHIP PROCESS (REAL ESTATE)

* The whole process can take 3-6 months

1. Property Purchase	Purchase real estate with a minimum value of 400,000 USD.
	Can be a single unit or multiple units, as per regulations.
2. Ownership Commitment	Retain the purchased real estate for a minimum of 3 years.
	Record the 3-year commitment as an annotation in the Title Deed and/or Notarized Sales Contract.
3. Official Valuation Survey	Authorities conduct an official valuation survey.
	Valuation report must confirm a minimum value of 400,000 USD.
4. Purchase Transaction	Pay the purchase price to the seller via a bank transfer.
	Support the transaction with bank receipts.
5. Investment Value Confirmation	Officially declare the value of the investment.
	Ensure the declared value is at least 400,000 USD at the time of the Notarized Sales Contract and/or ownership transfer at the land registry office.
6. Ownership Registration	Register the property under any foreign individual's name, including the applicant's spouse or children.
	Real estate transferred by the applicant's spouse or children after 12.01.2017 is not within the scope of the regulation.
7. Application Submission	Submit the completed application, along with all required documents.
	Submission facilitated through the Ministry of Environment and Urbanization, Land Registry Office.
